9. That I am fully aware that the grant or refusal of a visa is at the sole discretion of the U.S. Embassy or Consulate, and IBT Institute Pvt. Ltd. has neither claimed nor provided any assurance or guarantee regarding the approval of my visa application or the issuance of a U.S. visa. I further acknowledge that the upfront advance consultation fees and any charges paid by me to IBT Institute Pvt. Ltd. are non-refundable and non-transferable under any circumstances, regardless of whether my U.S. visa application is accepted or rejected by the concerned U.S. Embassy or Consulate.

10. That I understand that I am not entitled to a refund of any amount paid as an I-20 deposit to the university, which is explicitly mentioned in the offer letter as non-refundable. Furthermore, I acknowledge that the SEVIS fee paid to the U.S. Department of Homeland Security (DHS) and the

Embassy fee paid to the U.S. Department of State are also non-refundable, and I cannot claim these fees under any circumstances.

**11.** That I confirm IBT Institute Pvt. Ltd. has only provided me consultancy services on the basis of the above detailed documents provided and submitted by me, apart from consultancy service, IBT Institute Pvt. Ltd. has not helped me in obtaining or provided any financial assistance, bank statement, academic document, IELTS bands/certificates or experience certificate etc.. In event any of my document including above detailed academic/study documents, experience certificate/s, bank account statements/certificates etc. are found to be false, tampered, forged, fabricated or procured one, in such an event, I shall be solely liable and responsible for the same, as IBT Institute Pvt. Ltd. holds no responsibility or liability of any sort, for any of the document, which belongs to me.

**12.** That I am aware that Embassy/consulate of USA will take my interview for taking decision on my visa application and also I am aware that the immigration authority or any other authority at U.S.A can take my interview for making decision on my visa application and/or event at the airport after grant of USA study visa and even ask for additional documents and if I am unable to satisfy the said authority at the airport and/or if any of my academic document, experience, fund regarding document etc. is found to be not genuine, I can be denied entry rights in U.S.A. and/or even the Immigration Authority at New Delhi or at Airport in India can refuse my exit from the country. In that event I shall be liable and responsible for the same and any amount paid by me to IBT Institute Pvt. Ltd. and to the university/college/institute including visa application , fee, insurance etc. will be non-refundable and non-transferrable, as I shall be solely liable and responsible for my documents, acts and deeds.

**13.** That IBT doesn't guarantee the date of the embassy/consulate interview slot. This is completely dependent on availability of slots by the USA Embassy/consulate. I hereby agree that IBT is not responsible for delay in interview in case of non-availability of slots.

**14.** That no criminal case/FIR is filed or pending against me in India or anywhere else, which debars me from traveling overseas. However in event, my this declaration is found to be false and the university terminates my name and/or I am refused to exit from India or deported/sent back to India due to the said reason, I shall be solely liable and responsible for the same and shall have no claim towards IBT Institute Pvt. Ltd., its directors or any of its employee.

**15.** That IBT Institute Pvt. Ltd. or its Staff/Directors hold no responsibility or liability, in any manner in event the institute in which I have/shall take admission, is banned or closed down, in future and if in event, said institute terminates my study due to any reason whatsoever and in that event also the fees paid by me to the said University/college/institute and to even the Consultation and service fee/charges paid to IBT Institute Pvt. Ltd. will not be refundable.
